MINUTES OF MEETING HELD ON 5th SEPTEMBER 2023 PRESENT

23/095 APOLOGIES FOR ABSENCE

Cllr John Hendry. There were no other apologies for absence.

23/096 MINUTES OF THE LAST MEETING

The minutes of the meetings held on 1st August were agreed and signed as true records.

23/097 MATTERS ARISING

Closed Public Rights of Way – The Clerk informed the Council that there was no new information to report to Cllrs.

Severn Trent clearing and tidying at Pumping Station at Whaddon – The Clerk informed the Council that there was no new information to report to Cllrs.

23/098 COUNTY COUNCILLOR'S REPORT

This report had been circulated to Councillors and there were no questions. The ongoing problems with HGVs using Upton Lane to access the construction site at Matson was discussed. The lack of weight restriction signs is believed to be an issue and Cllr Williams agreed to bring this up again with Highways.

23/099 STROUD DISTRICT COUNCILLOR'S REPORT

Cllr Davies reported that the Local Plan Inspectors raised major concerns about motorway junctions 12 and 14. A six month delay to decision has been requested The cost to upgrade these junctions is believed to be in the region of £250m per junction. As neighbouring districts are not in the same place with their draft plans it means that Stroud District is the first to go through inspection this time round. Stroud District has a six year housing supply so should be safe from a developers' *free-for-all*. However, developers could put in applications and go to appeal. Councillor Davies stressed that this is dangerous territory, and the district is vulnerable. Small developments in Stroud Road and Naas Lane could be vulnerable to development.

It was confirmed that an application could be submitted and then a delay can be agreed. It was stressed that before an application is submitted is the time to negotiate for as good a development as possible – footpaths, open spaces, community centre, who will run it etc. This is without prejudice and the Parish Council can still object to the application.

23/103 SPEED AWARENESS SIGNS

Cllr Williams agreed to follow up on our Road Safety application.

23/104 WHADDON FIELDS

The Parish Council was asked by Hunts Grove Parish Council for a meeting to discuss the impact on local lanes should the proposed development go ahead. It was felt that this was very beneficial with representatives from Hunts Grove, Harescombe and Haresfield PC's and three Stroud District Councillors were also in attendance. It was decided that the Clerk should email Taylor Wimpey to try and arrange a separate date to examine their plans, as Cllrs were not available to attend the proposed consultation event due to short notice.

23/105 COTSWOLD CLIMATE ACTION CARBON NEUTRAL PROPOSAL

Cllr David Kaspar reported that the carbon problems were highlighted. The Parish Council took note but felt that the remedy was more strategic, and some proposals were unrealistic. It was felt that apart from everyone lowering their own carbon footprint, one of the best things that can be done is to source locally.

23/106 DEFIBRILLATOR TRAINING

The Clerk reported that she was working with the Village Hall Committee to put this on as part of a planned coffee morning to be held in October. The staff of Fagin's are also keen to join in, although the timing of this may be problematic for them.

23/107 STRUCTURAL CONDITION OF ST SWITHUN'S CHURCH

The Church Plan from the Churches Conservation Trust had been circulated. It was felt by Cllrs that it was very difficult to imagine where the amount of money involved to renovate this church would come from.

23/108 INFORMATION FOR COUNCILLORS

The Clerk reported that she was working with the Village Hall Committee to access some of the CIL money under guidance form GAPTC.

Cllr Paul Gaze reported that the hedge at the Hill Mead and Haresfield Lane junctions needs to be cut back as it is dangerous for pedestrians crossing the road.
